Lorena Boix Alonso is Head of Unit for Converging Media and Content, at DG Connect. She has served as Deputy Head of Cabinet to Vice President Neelie Kroes during Ms Kroes' time as Commissioner for the Digital Agenda and as Commissioner for Competition. Lorena has also worked at the European Court of Justice and the IPR-Helpdesk Project. She holds a Master of Laws from Harvard Law School.



Dr Jürgen Brautmeier is Chairperson of the Conference of Directors of the Media Authorities (DLM), in Germany. He has a wide range of experience in broadcasting regulation, having served as an advisor on broadcasting legislation to various Central & Eastern European governments, as well as being a founding member of the European Platform of Regulatory Authorities. He studied History, and English Language and Literature, at Dusseldorf and Cambridge Universities.



Nicola Frank is Head of European Affairs, and Head of the Brussels office, at the European Broadcasting Union (EBU). Prior to joining EBU, she worked for Media and Entertainment International, a federation of media and entertainment trade unions. While at the European Commission, Nicola managed an information and communication programme in the Mediterranean and the Near and Middle East. She has an M.A. in Islamic Studies, Modern History and French Literature.



Jean-François Furnémont is a founding partner of Wagner-Hatfield, a consultancy specialising in public affairs, policy, and regulation. He is a former Director General of CSA, an audiovisual regulatory authority in Belgium, and is a former Chairperson of EPRA. He was also a Member of the Board of RTBF, a Belgian public service broadcaster. He studied journalism at Université Libre de Bruxelles and International Relations and European policy at Université de Liège.

Emmanuel Gabla is a Commissioner at the Conseil Supérieur de l'Audiovisuel, the French broadcasting authority. Prior to this, he served in a number of government departments, including as Head of the Information & Communication Technology Department at the Ministry of Economy, and as an advisor on telecommunications to the Prime Minister. He is a graduate of Ecole Polytechnique and Telecom ParisTech.



Steve Gettings is Director of International Affairs at Ofcom, the UK's communications regulator. He has held several strategy and market monitoring roles at Ofcom, advising government on media plurality, and working on Ofcom's Communications Market Report and the International Communications Market Report. Prior to this, his work included roles with the BBC, Teachers' TV, Oxera and PWC.



Chris Hutchins is Vice President, European Policy at Liberty Global, a pan-European investor and operator of cable TV businesses. Chris has held several regulatory and legal positions within LGI and predecessor companies since joining them in 2000. He has previously worked at Burson Marsteller and the European Commission. Chris holds a Master of Laws in telecommunications and IT law from Strathclyde University.



Cornelia Kutterer is Director of Digital Policy at Microsoft EMEA, and is responsible for security and data access governance issues, as well as child safety and consumer policies. Cornelia was previously Head of the Legal Department at BEUC, the European Consumer Organisation, where she worked on policy around consumers' digital life and consumer protection. She holds a Master's Degree in IT technology and communication laws from the University of Strathclyde.



Professor Pierre Larouche is a Joint Academic Director of CERRE, Professor of Competition Law at Tilburg University, and Vice-Director of the Tilburg Law and Economics Center. He is also a Professor at the College of Europe (Bruges) and the Institut d'Etudes Politiques (Paris). Professor Bruno Liebhaberg is Director General at CERRE. He is a professor at the Université Libre de Bruxelles' Solvay Brussels School of Economics and Management (SBS-EM, ULB). He holds a Master in Management Sciences from the SBS-EM, ULB (1975) and a PhD from the London School of Economics and Political Science (1982).



Helena Mandic is Chairperson of the European Platform of Regulatory Authorities (EPRA), and Director of Broadcasting at the Communications Regulatory Agency (CRA), in Bosnia & Herzegovina. In addition to holding various positions within CRA, Helena was involved in drafting the Press Code of Bosnia and Herzegovina, along with laws on defamation, freedom of information and communications. She is a graduate of the Sarajevo Faculty of Law.



Tobias Schmid is Executive Vice President, Governmental Affairs at RTL Group and Head of Media Policy at Mediengruppe RTL Deutschland. He was previously Chairperson of the Board of the German Association of Commercial Broadcasters and Audiovisual Services (VPRT). Tobias holds a PhD in Law from Heidelberg and Freiburg Universities.



Professor Peggy Valcke is a Professor in Law at Katholieke Universiteit Leuven, and Director of the Interdisciplinary Centre for Law & ICT. Her research interests focus on the regulation of the info-communications sector and the interaction between info-communications law and competition law.
